#### THE PETITION OF JANE MASTEN

"To the worshipfull Justices of the County of Hunterdon now sitting at Trenton" on 26 October 1763, Jane Masten made the following petition: that she was a "poor wid'o and hath two children to maintain and (had) nothing but her labour to support herself and them." She had spun some worsted for Joshua Smith when she requested payment he "deny'd her pay" since he'd obtained a judgment against her for twenty eight shillings debt and one shilling and six pence, court costs. In the meantime, Jane had asked two weavers, Gershom Moore and Stephen Field, to examine the quality of the fabric. They declared that the worsted was "well spun" and that Jane was a "poor friendless widow and should be granted the sum due her."
